For the effective enforcement of provisions under N.D. Adt and monftoring of cases, a harcotics cell has been functioning under the economic offences wing of C.I.D. However, in view of urgency a Dedicated Narcotics Cell has been created which should function not only as a full time agency for action against drug traffickers, but should also as the nodal and co-ordinating agency for maintaining liaison and co-ordination with the other agencies, units and also with the Narcotics Control Bureau at the central level.

On the suggestion of Narcotics Control Bureau, the Dedicated Narcotics Cell will function under C.I.D. at Patna. Since during the last few year, large scale seizure of Narcotics Drugs has been noticed on Bihar-Nepal and Bihar-U.P. Borders, it has also been decided to setup operational teams at Muzafferpur, Purnea and Dehri. These operational teams will be headed by gazetted Police officers of the rank of Additional S.P./ Dy. S. P. Each Operational Team will consist of Intermediate supervisors of the rank of will napactor/Sub-Inspector who/not only collect inteligence of illigal trade in Narcotic Drugs but also ensure enforcement

A periodical review of the performance and liaison will be conducted every month and report submitted to I,G., C.I.D., D.G. of Police, Narcotics Control Bureau and other agency.
